STAGES OF DEMATERILISATION OF SHARE CERTIFICATES

1. Investor submits the share certificate to be dematerialised with MACT Securities.
2. Investor signs the relevant columns of the transfer forms for authorization.
3. MACT Securities will verify the Investor's identity by the Investor presenting Identification documents like Passport, Drivers Licence (take copy after sighting the original) and Utility Bills.
4. MACT Securities opens a CSCS Investment Account for the Investor as well as give a Clearing House Number.
5. MACT Securities will take these documents and the certificates to the Company Registrars Office for verification.
6. Registrar verifies the ownership and signature of the Investor. Dematerialises the certificate and sends copy to CSCS to credit the Investor's Account and retainsthe dematerialised certificate.
7. In case of doubt, the Registrar may demand signature specimen, like Bankers confirmation and / or evidence of purchase.
